I Captain John Ross of Balnagown Forasmauchas I am ordered to attend His Maiestie's service, and go abrod – and as it is necessary that I should appoint a proper & skilfull person for managing my Affairs, in the County of Ross, and particularly for lineing out and dividing such parts of my Estate in the said County as are not already under Tacks, and for granting Tacks to such Tenants on my Estate, as may require the same during my Absence. And having experience of the faithfulness and diligence of Alexander McCulloch my Servant at Balnagown. Therefore Will ve me to have made and Constitute, Likeas I hereby make & Constitute, the said Alexr McCulloch my Commissioner & Doer, in my Absence, to line out the farms in Westray & parish of Eddertown, and such other ffarms as may require lining out, and dividing in the Parishes of Kincardine, Loggie Easter, Kilmuire, Fearn, and Nigg, as it must tend greatly to the interest of the Tenants that every man's farm may be sett apart, and not running back & fore as they have been of Old. With full power warrand & Commission to the said Alexr McCulloch to value each farm according to the best of his skill & knowledge, and to put such a reasonable rent on each farm, without hurt to me or Tenants, as to him shall seem meet. And also with power and Commission to the said Alexr McCulloch to output and input Tenants, Issue Warnings and proceses of Removing in my name and his own, and to grant Tacks to the Tenants of their farms, for any Number of Years, not Exceeding Nineteen Years; which Tacks so to be granted by him shall be as sufficient & binding upon me my heirs & successors, as if the same had been Executed personally twixt me & my Tenants. And it is hereby specially provided & declared that the said Alexander McCulloch at filling the Tacks to be granted by him, shall give always preferrence to the Tenants in possession upon equal terms with any other Offering. And this power & Commission to Continue & endure untill the same is revocked & recalled by a writing under my hand. The said Alexander McCulloch being always accountable to me for his Conduct & management of my Affairs intrusted to him in my Absence. And I Consent to the registration hereof in the books of Council and Session, Commissary Court books of Ross or others Competent, therein to remain for preservation, and as need be, to receive Execution in form as Effiers(?). And thereto I Constitute Donald Davidson Writer in Tain my pror &c.
